**Present:** Mayor: Barry Gehrig. Councilmembers: Rob Fauber, Tom Knapp, Jennifer Lompe, and Audrey Davis. Clerk: Kristen LeDoux. Public: Pat Malson and Anita Bartlett.

Mayor Gehrig called the regular meeting to order at 7:00 p.m.

**NEW BUSINESS:**

Pat Malson: Mr. Pat Malson thanked the Council for renting the meeting room to Hunter's Safety. Mr. Malson donated two hundred dollars back to the Town.

Resolution 202305: Resolution 202305 is a resolution amending the fiscal year end 2023 budget for water, sewer, and street repairs.

Park Camping: The Council discussed possible camping options for the park. They will check and see if the camping rules are in ordinance before making any changes.

Middle Fork Ranch: Mr. Toby Pierson would like to extend the water line from the already existing tap to a barn. The water would only be used for drinking and not watering livestock. Councilwoman Lompe moved to approve the water line extension as presented. Councilman Knapp seconded. Motion carried.

Animal Complaint: The Council was presented with an animal complaint. Mayor Gehrig will visit with law enforcement and Mr. Crago regarding options for addressing the complaint.

Building Permit 202304: The Council was presented with a building permit from Mr. Tom Phipps. Mr. Phipps would like to build a garage on his Pierson Street property. Councilman Fauber moved to approve the building permit as presented. Councilman Knapp seconded. Motion carried.

**Updates/Correspondence:**

- There is a JOCO meeting at Town Hall on Wednesday at 8 a.m.
- The law enforcement and fire department radio system are currently down due to a lightning strike.
- The generator at the well was running continuously and wouldn't shut off after the storm. It has since shut off and everything is operating normally.
- The generator at the lagoons is not working after the storm.

- The Powder River Fire District is still reviewing the proposed contract.
- Councilman Fauber would like weeds pulled on the South end of the RWCC.

**OLD BUSINESS:** None.

**LEGAL ISSUES:** Mr. Crago requested that the Council not pay him for the month of June. The Council agreed to pay him his contracted wage as usual.
