REGULAR MEETING KAYCEE TOWN HALL April 12, 2016 7:00 P.M.

<u>Present</u>: Council Members: Crosby Taylor, Barry Gehrig, Audrey Davis, and Jennifer Lompe. Mayor: Tom Knapp. Public Works Director: John Cohee. Police Chief: Leo Kremers. Town Attorney: Barry Crago. Clerk: Kristen LeDoux.

Mayor Knapp called the meeting to order at 7:00 p.m.

<u>Maintenance Report</u>: Mr. Cohee informed the council of current water usage and repairs that have been made to the heating system at the Red Wall Community Center.

Police Report: Chief Kremers reported that he has been taking care of the recent increase in animal complaints.

New Business:

<u>Road Closure</u>: The council was presented with paperwork from Ms. Peggy LeDoux requesting partial closure of Nolan Avenue for LeDoux Days, which will take place June 17^{th} – June 19^{th} . Councilwoman Davis moved to approve the partial road closure for LeDoux Days, seconded by Councilman Taylor. *Vote:* 5 ayes. **Approved.**

<u>WAM Delegate</u>: Mayor Knapp informed the council that a voting delegate is needed for the WAM Convention to be held in June. Councilman Taylor moved to nominate Mayor Knapp as the voting delegate, seconded by Councilwoman Lompe. *Vote: 5 ayes. Approved.*

<u>Resolution 201602</u>: Resolution 201602 is a resolution to seek funding for the Kaycee Landfill Closure. Councilman Taylor moved to approve resolution 201602, seconded by Councilwoman Davis. *Vote: 5 ayes. Approved.*

<u>Letter of Approval</u>: Mr. Crosby Taylor, representing Taylor's Invasion Bar, requested a letter of approval to present to the City of Buffalo to cater the Rocky Mountain Elk Foundation Banquet, which will be held at the Bomber Mountain Civic Center in Buffalo, WY on May 7, 2016. There being no public comment, Councilwoman Lompe moved to approve the letter of approval for Taylor's Invasion Bar, seconded by Councilman Gehrig. *Vote: Councilmembers Gehrig, Davis, and Lompe, and Mayor Knapp voting aye, Councilman Taylor abstaining.* **Approved.**

Committee Reports/Correspondence/Updates –

• Mayor Knapp informed the council that Mr. Craig Walker has requested information regarding the town's easement so that he can construct a fence along

- the edge of his property. The council discussed what area the easement covered and maintenance of the area that would be left between fences.
- Mayor Knapp stated that he has not heard more from the Recreation Board but that they will be meeting with the Commissioners soon.
