

REGULAR MEETING
KAYCEE TOWN HALL
September 14, 2021
7:00 P.M.

Present: Mayor: Crosby Taylor. Councilmembers: Barry Gehrig, Tristan Allen, Audrey Davis, and Ethan Knapp (via telephone). Public Works: K. Rex Maxwell. Law Enforcement: Deputy Shane Greet. Public: Larry Sandvick and Jennifer Douglas.

Mayor Taylor called the regular meeting to order at 7:00 p.m.

MAINTENANCE REPORT: Mr. Maxwell informed the Council that the water main leak has been repaired. Some areas along the water line are washed out and will need dirt work to keep it fully covered. On August 14th there was a power outage at the wells and the generator was fried.

LAW ENFORCEMENT: Deputy Greet gave the Council his monthly report for the month of August and entertained any questions from the Council.

NEW BUSINESS:

Weeds: The Council discussed the number of weeds around town this year. They will review the ordinance regarding weed enforcement.

Constitution: Mayor Taylor proclaimed September 17th – 23rd to be Constitution Week.

Flags: The flags on Main St. are in poor condition. Councilman Gehrig will visit with the Auxillary group about taking them down soon.

Larry Sandvick: Mr. Sandvick stated that his meter pit is not completed. He purchased a 1" line and currently has a 3/4" installed. Mr. Maxwell said that he is currently waiting on parts that are backordered. Mr. Sandvick also asked if he can add an additional water line. The Council will review the ordinance and his current water agreement to see what his options are.

OLD BUSINESS: None

LEGAL ISSUES: It is the recommendation from Mr. Crago that Kale Morse completes his subdivision first and then completes the town annexation.

MINUTES: The minutes from the regular meeting held on August 24th were approved as presented.
