Mayor Knapp called the meeting to order at 7:00 p.m.

<u>Maintenance Report</u>: Mr. Russell Cohee updated the council on the sewer lagoon permitting, recent water issues, and the repairs to the drip system in the town park.

<u>Police Report</u>: Police Chief Kremers distributed his monthly police report and entertained questions from the council.

New Business:

<u>Public</u> – Mr. Keith Eitel updated the council on his impending departure and the council scheduled a date for him to haul the last load in the compaction trailer.

<u>Arbor Day Proclamation</u> – Mayor Knapp read the Arbor Day Proclamation, which proclaimed May 14th, 2014, as Kaycee Arbor Day.

<u>Poppy Day Proclamation</u> – Mayor Knapp read the Poppy Day Proclamation, which proclaimed May 16th, 2014, as Kaycee Poppy Day.

<u>1st Reading Ordinance 201402</u> – Ordinance 201402 is an ordinance which will make it a violation in the Town of Kaycee to permit a house party where minors are present. Councilwoman Lompe moved to approve Ordinance 201402 on first reading, seconded by Councilman Collins. *Vote: 3 ayes.* **Passed**.

1st Reading Ordinance 201403 – Ordinance 201403 is an ordinance which will make it a violation in the Town of Kaycee for failure to maintain motor vehicle liability coverage. Councilman Collins moved to approve Ordinance 201403 on first reading, seconded by Councilwoman Lompe. *Vote: 3 ayes.* **Passed**.

<u>Building Permits</u> – The council was presented with a building permit request from Mr. Crosby Taylor. Mr. Taylor is requesting permission to construct a single family residence on his property located on lot numbers two and three, Block Three, in the Buell Addition, at 205 and 215 Campbell Avenue. Councilwoman Lompe moved to approve the building permit submitted by Mr. Crosby Taylor for lot numbers two and three, Block Three, in the Buell Addition, at 205 and 215 Campbell Avenue, seconded by Councilman Collins. *Motion Carried*.

The council was presented with a building permit request from Mr. John Garro. <u>Bid Opening</u> – The council received one sealed bid for the trash hauling contract. The bid was for \$750.00 per load and was received from Taylor Trucking.

<u>Market Opinion</u> – The council was presented with a market opinion of the property that the Town of Kaycee owns, located at 122 Second Street.

<u>Updates</u> – The mayor informed the council that there will be a KBJ Joint Powers Board meeting at the Red Wall Community Center on Wednesday, May 14th, at 8:00 a.m. Mayor Knapp also updated the council on the progress of the street project and commended the Kaycee FFA for all the sand bags they had filled as part of their community service program.
