## **NEW BUSINESS:**

2015 WAM Winter Workshop Voting Delegate – Councilwoman Lompe moved to approve Mayor Knapp as the official voting delegate at the 2015 WAM Winter Workshop, seconded by Councilman Collins. *Vote: 4 ayes. Approved.*Updates – Mayor Knapp and the council discussed the progress of the sewer lagoon permit, the low fire hydrant flow testing results, and progress on the grant funding for the water tank replacement. The council and Commissioner Eitel also discussed street lighting and the sewer main that was installed when the new Powder River Fire District building was built.

Mayor Knapp stated that Mr. Scott Gruntmeir, Bald Mountain Sanitation, will present a proposal for the town to outsource sanitation services at the November 25<sup>th</sup> council meeting.
